

Appendix A: Consolidated indicator overview for Circular No. 88 (2022)

Appendix A sets out the 306 municipal indicators¹ introduced by MFMA Circular No. 88 and differentially applied across four categories² of municipality: metro; intermediate city; district and local municipality. Each category of municipality reports on a smaller sub-set from this overall catalogue of indicators. Each indicator is placed a readiness scale of Tier 1 (T1) - Tier 4 (T4) per municipal category. Only Tier 1 - Tier 2 indicators apply in the 2023/24 period.

Appendix B provides the Technical Indicator Descriptions (TID) for each of these indicators setting out the indicator rationale, definition, calculation details, data elements and more.

Appendix C provides an overview of revised, clarified and new indicators in comparison to the 2021 Circular No. 88 addendum update. This is relevant for all municipalities, but particularly for metropolitan municipalities that have developed standard operating procedures for earlier iterations of the affected indicators.

Appendix D provides guidance as it relates to planning for outcomes and outcome indicator targets.

The indicators in MFMA Circular No. 88 are organised by sector and outcome, applying a results-chain logic. They have been adopted for implementation in the 2022/23 local government financial year by the Joint Planning, Budgeting and Reporting Reform Steering Committee with institutional representation from across the centre of government.

Based on the experience of MFMA Circular No. 88 implementation to date, and with the benefit of sector and municipal feedback, there are not any substantive expansions to the indicators. The following tables gives guidance on codes and colouring per sector.
