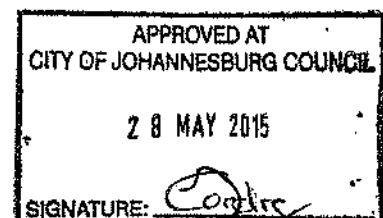
- 1 That Council approve the loan agreement of up to R1.8 billion between the City of Johannesburg and the Development Bank of South Africa ("DBSA").
