DRAFT BUDGET 2016/2019

In the ordinary council meeting which was held on the 30 March 2016 the Mayor tabled the report on the Draft Budget 2016/2017. In his presentation he stated that the budget has increased by R3 820 705 from 2015/2016 Financial year. The escalation in budget is caused by the increase of staff costs as from 2016/2017 financial year.

Determination of Salary Increase:

- Salary increase of 6.6% and 2.5%
- The organizational structure is still on review stage therefore the salary budget is exclusive of prioritized posts.

General expenditure

The general expenditure has decreased by **R2 914 471**, and other expenditure increased by R856 019, which is decrease by 1% and increase by 16% respectively.

Repairs and Maintenance

The repairs and maintenance has increased by **R1 300 500**, which is 28 percentage increase comparing to last financial year. The total amount budgeted for repairs and maintenance is **R4 870 500** for 2016/2017 financial year.

Provisions

The budget for the provision has increased by **R313 298** which is **6%** increase. The total amount budgeted for the provisions is **R5 060 234** for 2016/2017 financial year.

Capital Expenditure

The budget for capital budget has decreased by R22 047 091, which is 24% decrease comparing to 2015/2016 financial year. The total amount budgeted for the capital expenditure is 112 965 591 for 2015/2016 and R90 918 500 for 2016/2017 financial year.
