


## **KWADUKUZA MUNICIPALITY**

**ANNUAL REPORT 2005/6** 

### Acting Municipal Manager, Mr WT Byrnes



The tabling of the Mayor's Annual Report is a legislative requirement giving account to the Council's constituency of the progress made by Council in meeting its Constitutional Objectives; namely

- a. to provide democratic and accountable government;
- b. to ensure the provision of services to communities in a sustainable manner;
- c. to promote social and economic development;
- d. to promote a safe and healthy environment; and
- e. to encourage the involvement of communities and community organisations in the matters of local government.

As Acting Accounting Officer and Head of Administration I am pleased to report that considerable progress was made during the year under review.



In order to assist in providing a more comprehensive report the following needs to be highlighted:

- Financial Management: The financial administration faced an enormous backlog resulting from the amalgamation of the three local authorities. Although we have not yet fully reached our objectives in this regard, a skills gap analysis and focused in-service training ensured that accounting and cash flow management capacity (inclusive of debt collection), as well as skills, improved considerably during the year under review. The Municipality engaged the services of a consultant to assist in the preparation of the 2005/06 Financial Statements. Part of the terms of reference of the consultant was to transfer skills and capacitate Municipal officials. I am confident that the momentum of skills development will continue and that the results will even be even greater in the 2006/2007 Financial Year.
- Organigram: During the year Council adopted a revised Organigram. The new staff structure is leaner in respect of its top structure and thus more cost effective. Great care was taken to ensure that the new structure will meet the demands for service delivery as informed by the IDP. Special attention also ensured that the staff structure of the Finance Department will meet the needs for adequate financial management and control.
- Capacity : In spite of great strides made in the filling of vacancies and skills development all departments operated for considerable periods without their full complement of staff as per the revised Organigram. The fact that the municipality operated for 7 months of the financial year without a Municipal Manager also impacted negatively on service delivery. This was further complicated by the resignation of some of the Senior Management in the organisation. I am however confident that we have made considerable progress towards ensuring that the municipality has the necessary skills and capacity to meet the expectations of both Council and the community we serve.



 Policy development: Council has made great strides in policy development and implementation. Landmarks in this regard was the adoption in October 2005 of a Supply Chain Management Policy which meets the very prescriptive requirements of the Local Government: Municipal Finance Management Act No. 56 of 2003 and a revised Human Resources Policy that introduced uniformity of staff rules and benefits in February 2006.

I wish to thank all the staff for the valued contribution they have made towards service delivery during the year. In particular I want to thank Management for their support without which I certainly would not have been able to meet my obligations as Acting Municipal Manager.

I also have to thank the Mayor, Speaker and Councillors for their dedication and devotion to the cause of good, efficient and effective governance of the Municipality. With such inspired and dedicated leadership this Municipality will grow, thrive and prosper in the future.

As a Municipality we are acutely aware of the responsibility entrusted upon us in terms of the constitution of the Republic and its legislation - to be an efficient and effective developmental local government and we are indeed making every effort to ensure such delivery.

The Municipality has a responsibility to government and our people to create employment and a better life for all our residents. We have witnessed both quantitative and qualitative changes in the sphere of local government. This has by no means been an easy process, critical developmental challenges stood in the way of our people's quest for a better life and it is through the diligent pursuit of our vision which by 2010 KwaDukuza:

"Will through unity and good governance be an economic powerhouse, delivering services in an affordable and sustainable manner within a safe and healthy environment."



Council has developed an Integrated Development Plan, encompassing a set of strategies, programmes and projects aimed at coherently addressing the following critical developmental challenges:

- Provision of basic services
- Improved Service Delivery
- Develop our People
- Address poverty and unemployment
- Manage the health environment and the HIV/AIDS pandemic
- Ensure strict credit control

We have developed systems, structures and provided the resources to make significant contributions towards the realization of the 2010 dream by programmatically tackling these developmental challenges and it is aptly acknowledged at this time, as we stand at the half way mark, that we can be proud of our past service delivery record and we are indeed confident of our future.

Key amongst our efforts to broaden access to basic services, we based our priorities, strategies and programmes on the knowledge that only 47% of the population had access to sanitation infrastructure. Only 41% of the households had access to refuse removal service, only 49% had access to clean drinkable water inside their dwellings, and 68% had access to energy (electricity).

The private sector is a major player in employment creation and poverty eradication. It is common knowledge that KwaDukuza is one of the fastest growing and developing areas when it comes to commercial and up-market residential property market.



The upward swing in the value of private sector investment in our area as shown by the mushrooming of exclusive golf estates of international repute, shopping complexes and light industries gives us confidence that the private sector is contributing massively to the fight against unemployment and poverty.

The total operating budget for 2005/06 stood at **R264m** and the income **R279.6m**. The sources of revenue were split in percentages inter alia- Electricity **48.17%**, Assessment Rates **30.26%**, Refuse **5,32%**, Grant Funding **8,41%** and Other **7,84%**. Salaries, Wages and Allowances were capped below **33%** of the total operating budget.

The total capital budget stood at **R89m** financed both internally (approx R10mill) and externally through equitable share allocations, DBSA Loan R6,5m, MIG Funding and funding from the Depts. of Housing, Minerals and Energy Affairs.

### Location and area of jurisdiction

The KwaDukuza Municipality's area of jurisdiction is approximately 630 square km in extent. It has a permanent population of about 170 000 which during peak holiday seasons, increases to over 200 000. The KwaDukuza Municipality's area of jurisdiction stretches from the Zinkwazi River in the north to the Tongaat River in the South. It borders on four Municipalities, viz, the Municipalities of eThekwini, Ndwedwe, Maphumulo and Mandeni. It is one of the four municipalities that make up the llembe District Municipality.

KwaDukuza Municipality is the district node and dominant commercial centre in the Ilembe District. KwaDukuza Municipality occupies a coastal and inland stretch of approximately 50 km in length and 14km in width. The area consists of a variety of clustered and ad hoc settlements and small towns which are linked to each other by a well-developed network of roads and rail infrastructure. The key feature of the KwaDukuza Municipality is the N2 Development Corridor. KwaDukuza Municipality is also strategically located between two major ports, viz, Durban and Richards Bay. This corridor gives KwaDukuza Municipality the advantage of, and opportunity to strategically re–align and develop the district into a competitive and attractive investment destination.

### History

The population dynamics of the KwaDukuza Municipality is highly diverse due to its multicultural composition as well as its rich settlement history and cultural heritage.

The history of this area is epitomized by its very close links to the Zulu Nation and King Shaka, the great warrior and statesman whose Royal Settlement was called Dukuza, and was situated where the town of KwaDukuza (previously Stanger) stands today. King Shaka's gravesite is situated in KwaDukuza. A memorial stone was erected over King Shaka's grave in 1932 by the Zulu nation and was declared a national monument a few years later. The memorial stands in a garden where an interpretive centre was erected about ten years ago. Other historical sites which are related to the history of King Shaka



and situated in reasonably close proximity to his Memorial stone in KwaDukuza are the Mavivane Execution cliff and High Rock. The observation rock is where King Shaka watched his impis. This rock is now a national monument and is situated in the Groutville area of the KwaDukuza Municipality.

The Zulu speaking inhabitants of this area have always referred the town, previously named Stanger, as "KwaDukuza".

As the Zulu name of KwaDukuza has existed for many generations and is of great significance to the Zulu nation, it was decided by the Council to change the name of the town to KwaDukuza.

This name change from "Stanger" to KwaDukuza was approved by the Minister of Arts and Culture on the advice of the South African Geographical Names Council and was published in the Government Gazette under Notice number 113 of 10<sup>th</sup> February 2006.

The KwaDukuza museum is situated diagonally opposite to the King Shaka Monument and Interpretive Centre, in what is now aptly known as King Shaka Street (previously Couper Street/King George Road).

This museum's themes relate mainly to the settlement history and culture of the indigenous Zulu people of the area, the Colonial era, and the establishment of the sugar industry, the sugar cane mills and farms owned by the sugar barons such as Sir Liege Hulett. He employed and settled labour from India to work on the cane farms and many sugar cane mills in the area. For this reason there are certain areas of the KwaDukuza Municipality which have a distinct Eastern ethos.

The King Shaka Cultural Heritage Tourism Trail is in process of being implemented in KwaDukuza in honour of the heritage that King Shaka left our Country. This project is also known as the "Gateway to the Zulu Kingdom" of KwaZulu-Natal.



The Municipality of KwaDukuza also boasts being the home of the first African to win the Nobel Peace Prize, Chief Albert John Mvumbi Luthuli. During the month of August 2004 South Africans from all walks of life joined the people of KwaDukuza in celebrating the life and times of this Son of the Groutville area of KwaDukuza Municipality. This Municipality's tourism has also been boosted by the declaration of Chief Albert Luthuli's House as a National Monument. Coupled with this was the restoration of Chief Luthuli's Grave as well as the renovation of Church in which Chief Albert Luthuli's body lay in state. Chief Luthuli was also a Deacon of the United Congregational Church.

A statue of Chief Albert Luthuli which was unveiled by His Excellency President Thabo Mbeki on 21<sup>st</sup> August 2004, was erected in the garden of the Municipal Offices of KwaDukuza (Stanger) on the corner of Chief Albert Luthuli and King Shaka Streets. The other street bordering the Municipal Offices, previously known as Rood Street, was renamed Mahatma Gandhi Street. The old First National Bank Building which was acquired by this Municipality, was renamed General Justice Gizenga Mpanza Building on 10 September 2005. Jackson Street was renamed Gizenga Street on 10 September 2005. General Gizenga Mpanza was one of the Commanders of Umkhonto Wesizwe who fought in the Wankie Operation and Sipolilo Campaign in Zimbabwe under the Luthuli Detachment.

The plinth structure on which the statue of Chief Albert Luthuli stands has two round plaques bearing the following inscription in English and isiZulu which reads as follows: -

"May KwaDukuza which is the home of iLembe (King Shaka), Mahatma Gandhi, Chief Albert Luthuli and M.B. Yengwa be a fount for nation building, a place of peace and unity. Let it be a place of peace and hope.

As President-General of the ANC at the time, Chief Albert Luthuli was instrumental in actions which lead to the drawing up of the Freedom Charter which involved the Kliptown gathering of 1955, and which is reflected in the writing of the democratic constitution of our Country. On 27<sup>th</sup> June 2005, a People's Assembly was held in the Luthuli Centre at Groutville in honour of Chief Albert Luthuli as one of the great pioneers of the establishment of a truly democratic system of government for this Country.

### Economic, Social, Infrastructural and other Development

Investment opportunities range from the tourism sector, light industry, communications and IT, transport and specifically agriculture in the form of sub-tropical fruits, vegetables, sugarcane and flowers. The main economic sectors are tourism, sugar, forestry, agroindustrial manufacturing, furniture manufacturing, clothing, plastic products and paper manufacturing and paper products. Holiday letting and exclusive elite residential and golf estates property development is one of the highly prized unique selling points of the area.

On 14<sup>th</sup> April 2005, an official launch of a partnership between the KwaDukuza Municipality and the Development Bank of South Africa (DBSA) took place. This very prestigious event was attended by among others, the Honourable Premier of our Province, Sbusiso Ndebele, Honourable MEC for Local Government and Traditional Affairs and Housing, Mike Mayuyakhulu, The Mayor of KwaDukuza Municipality at that time and present Mayor Cllr. S.S. Gumede, The then Honourable Speaker Cllr. S.W. Mdabe, and representatives of the DBSA.

The KwaDukuza Municipality is acutely aware of the responsibility entrusted to it in terms of the Constitution of the Republic and legislation to function as an efficient and effective developmental local government body.

The DBSA has in the past provided, and continues to provide funding and other forms of assistance for the development of our community and in so doing have approved a loan application for an electricity upgrade for both domestic and industrial use in the sum of R43m and R3m for capacity building. The R43m will benefit the 1<sup>st</sup> economy in the main, but addresses simultaneously the challenges facing the second economy – e.g. job creation and poverty eradication.



The Development Bank has been assisting this Municipality for years and a sound relationship has developed between the Bank and the Municipality. The Municipality has been the beneficiary of grant funding from the Bank to augment the Management Assistance Programme allocation by Government which is aimed at the improvement of the capacity of the Municipality, to improve the handling of the major administrative and management problems encountered by it.

It must be recorded that a further capacity building grant of R300 000 was also approved by the Bank as a vehicle to enhance efficiency in the main, aimed at improving this municipality's capacity to manage all spheres of its administration; improve its ability to plan and manage the massive growth mentioned, and assistance in processes leading to development of middle income housing in the area of jurisdiction of this Municipality.

### Land use

The dominant land-use outside of the urban areas of the KwaDukuza Municipality is sugar cane plantations interspersed along the coast and in some inland areas with forestry plantations. Land taken up by other forms of agriculture is limited. The primary rural landform is agriculture with farmhouses, compounds and smaller rural settlements dispersed throughout the area. The only major traditional settlement within the area is located in the northwest portion of the Municipal Area.

The urban landscape in the KwaDukuza areas is diverse, and the area is home to major formal and informal residential areas. The southern portions of the coastline are formally developed and include areas such as Ballito and Salt Rock. Developments in these areas are generally focused on the middle to high- income (up market) holidaymakers. The coastline to the north of Salt Rock is relatively underdeveloped with only smaller coastal

From Table 1 it follows that the KwaDukuza Population is almost equally balanced between the Male (49.5%) and Female (50.5%) gender segments.

The KwaDukuza youth segment of the population has a large base, and the total number of people under the age of 19 years comprises 37.8% of the total population, and the percentage of the population which is 34 years or younger comprises 68.4% of the total population.



The age group 65+ represents only 6% of the total population. It is interesting to note that the Male component in the age group 65+ comprises a very small percentage of the total population, namely only 1.8%.

From Table 2 it follows that there are almost 42000 households in KwaDukuza. The Total population in 2001 was almost 172000 people.

The African population comprises approximately 71% of the total population, the Indian or Asian group 23%, the White group 5% and the Coloured group approximately 1%. The average household size is approximately 3.6 persons per household.
