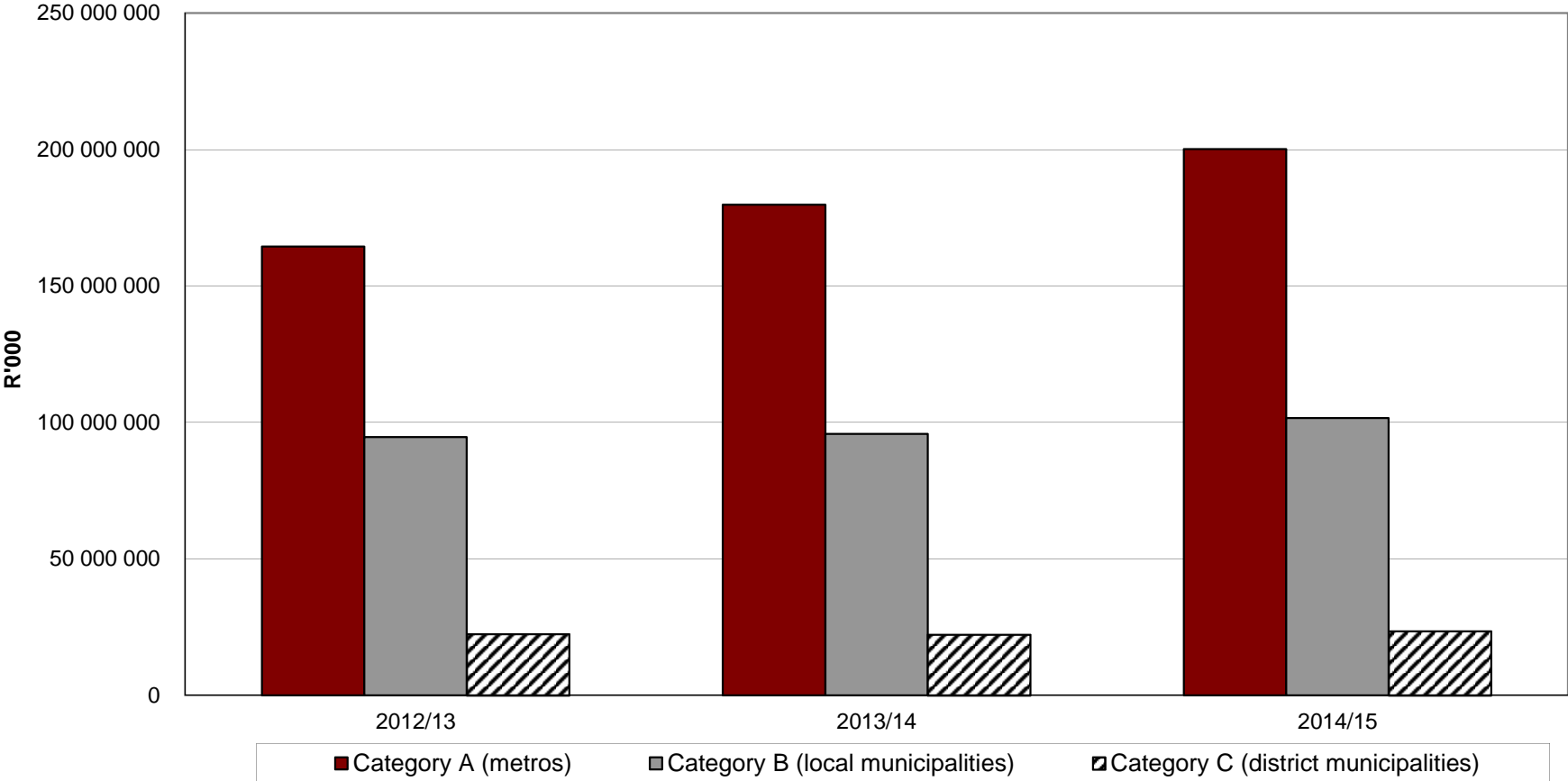
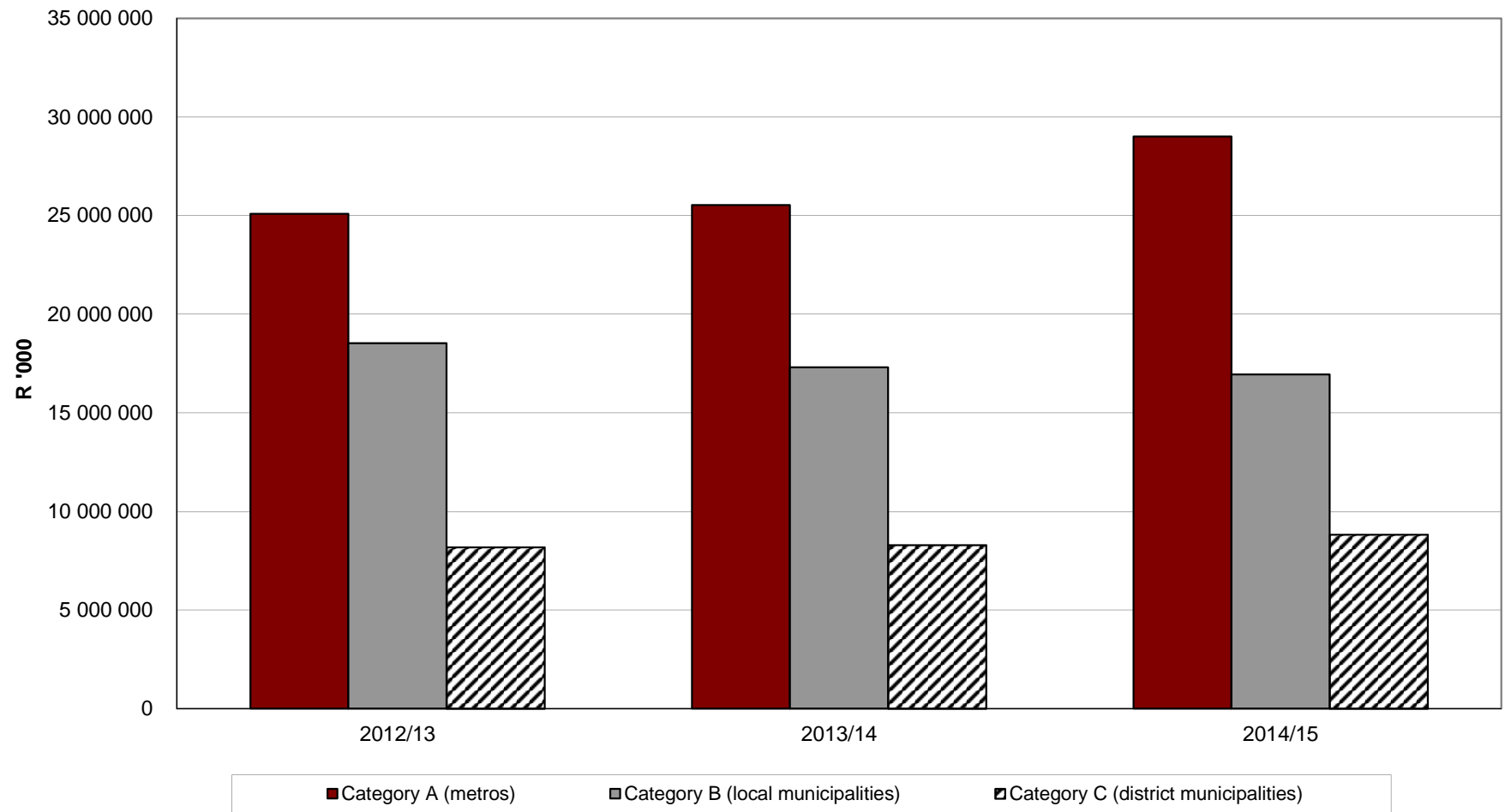


**Figure 1: Aggregated budgeted expenditure per category,

2012/13 - 2014/15**

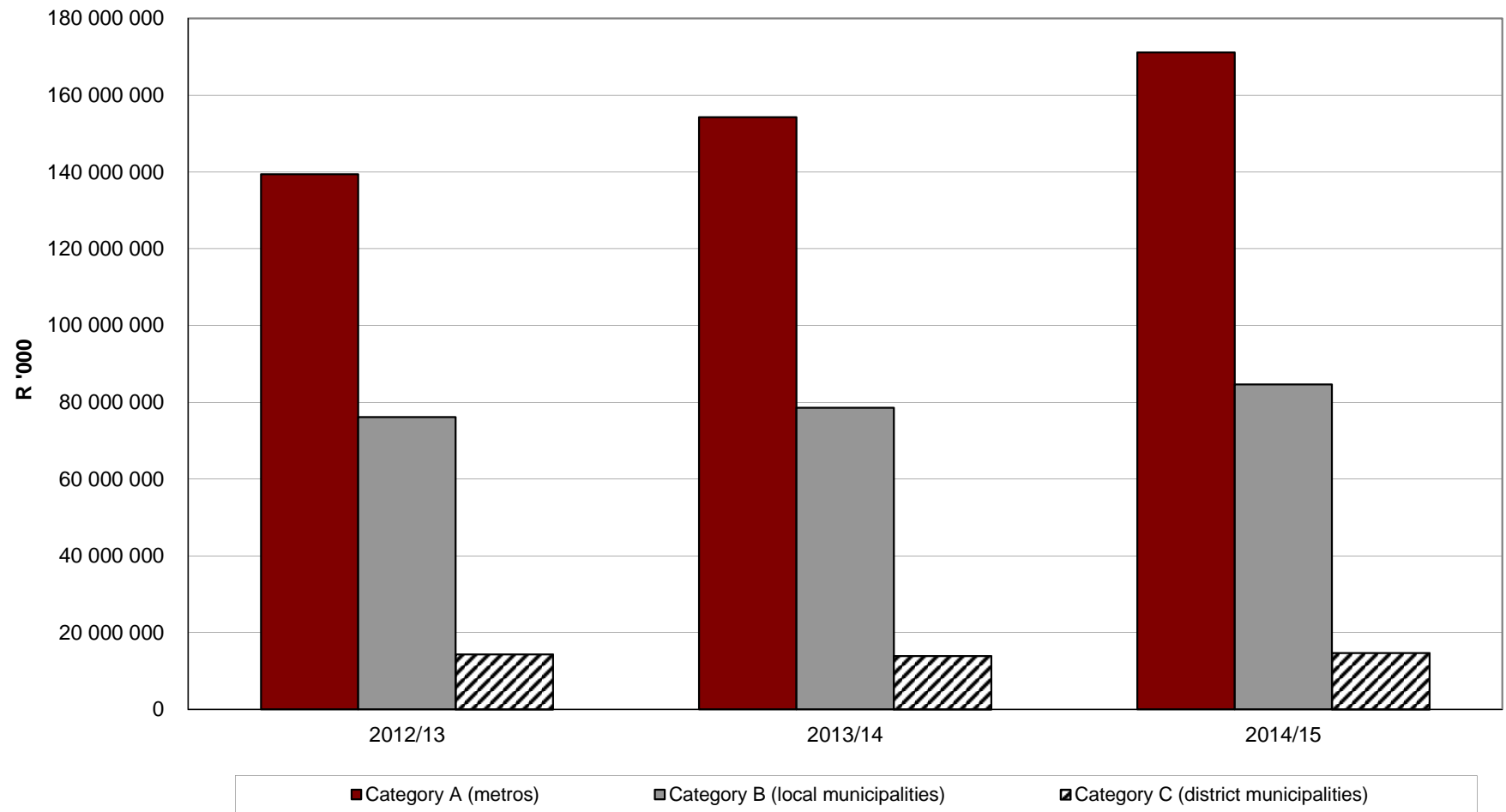


Figure 2: Total operating and capital expenditure per province, 2012/13 - 2014/15

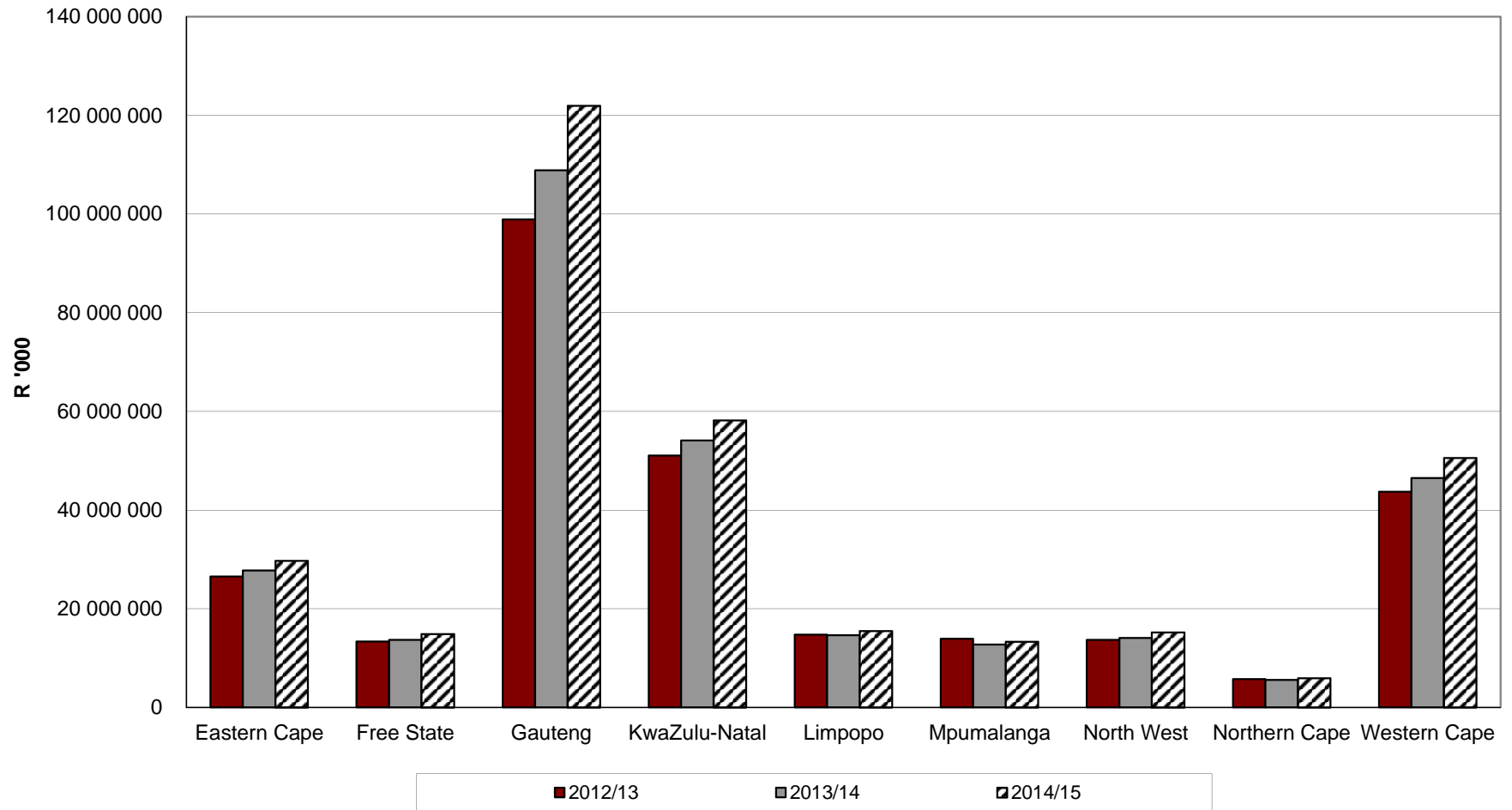


Figure 2.1: Budgeted capital expenditure per province, 2012/13 - 2014/15

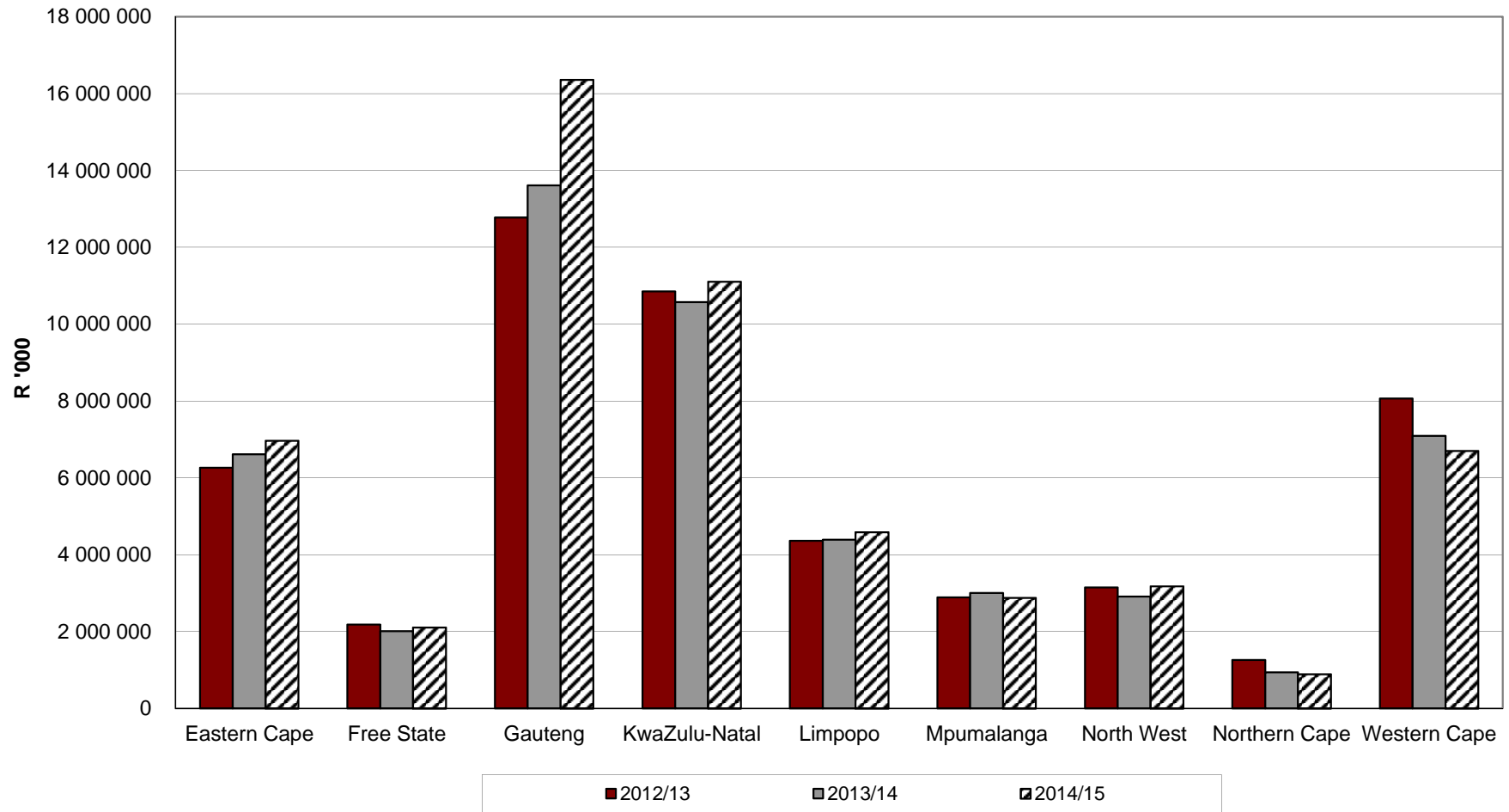
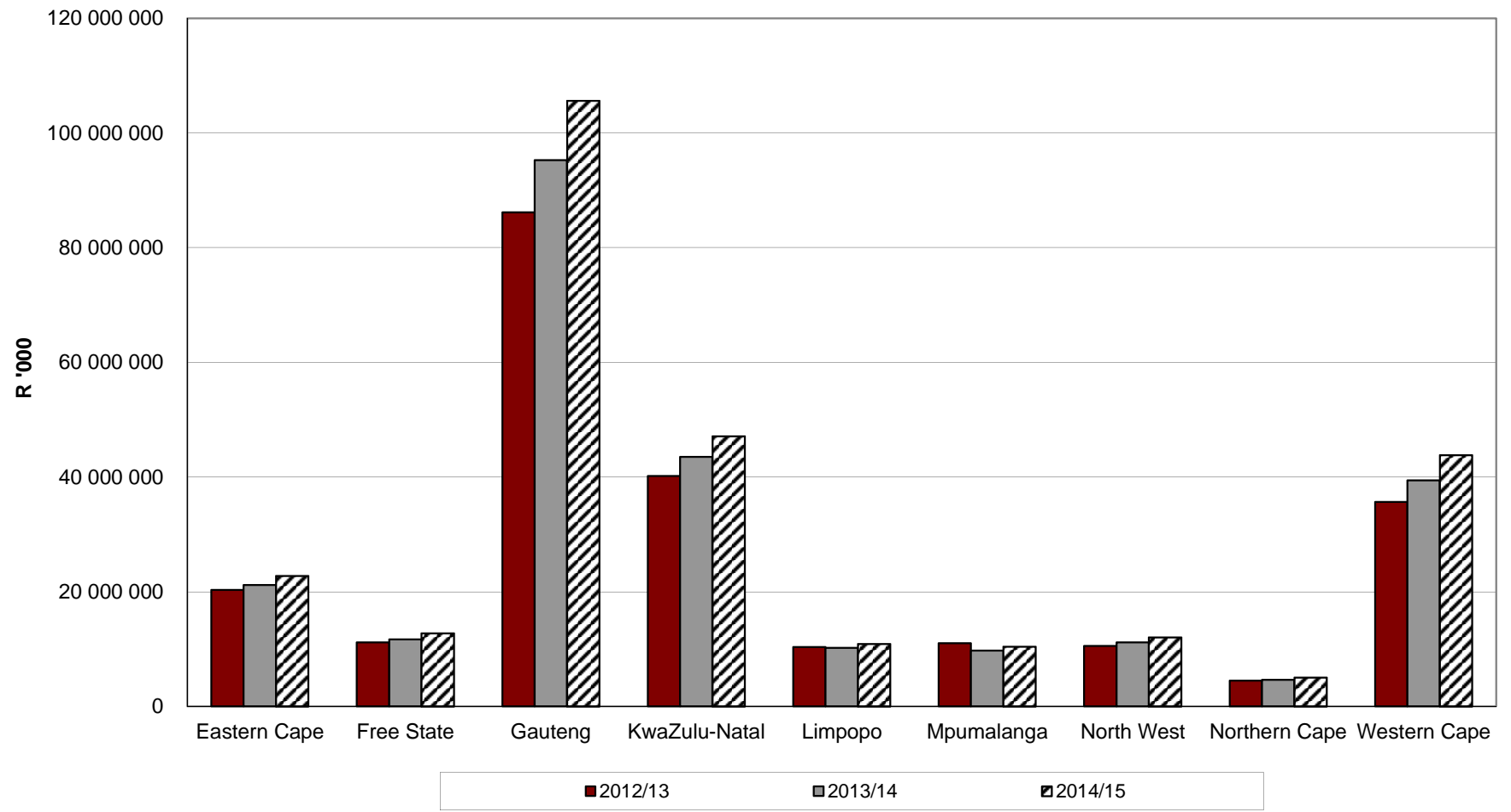


Figure 2.2: Budgeted operating expenditure per province, 2012/13 - 2014/15

2012/13 - 2014/15**

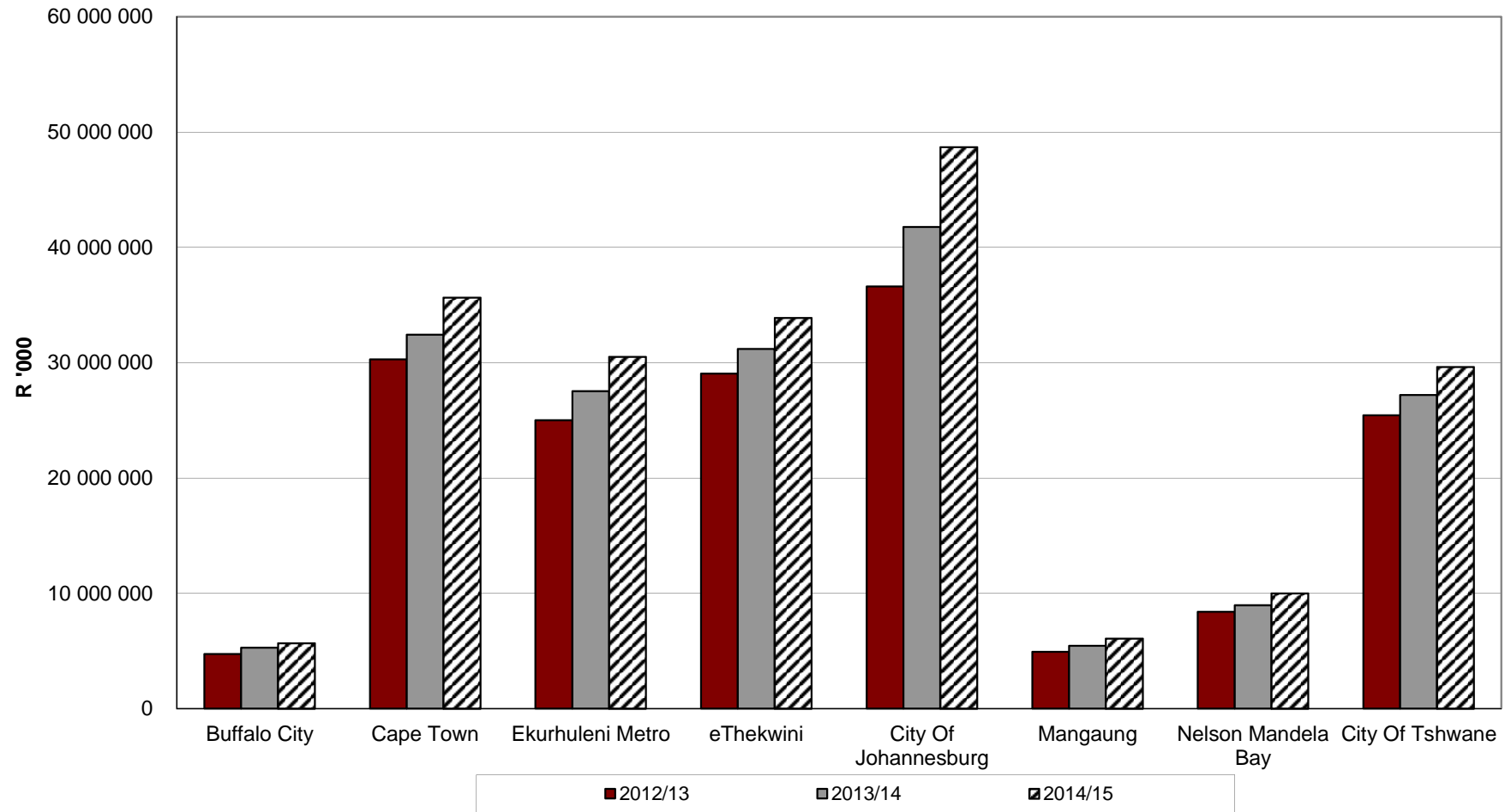


Figure 3.1: Budgeted capital expenditure per metro, 2012/13 - 2014/15

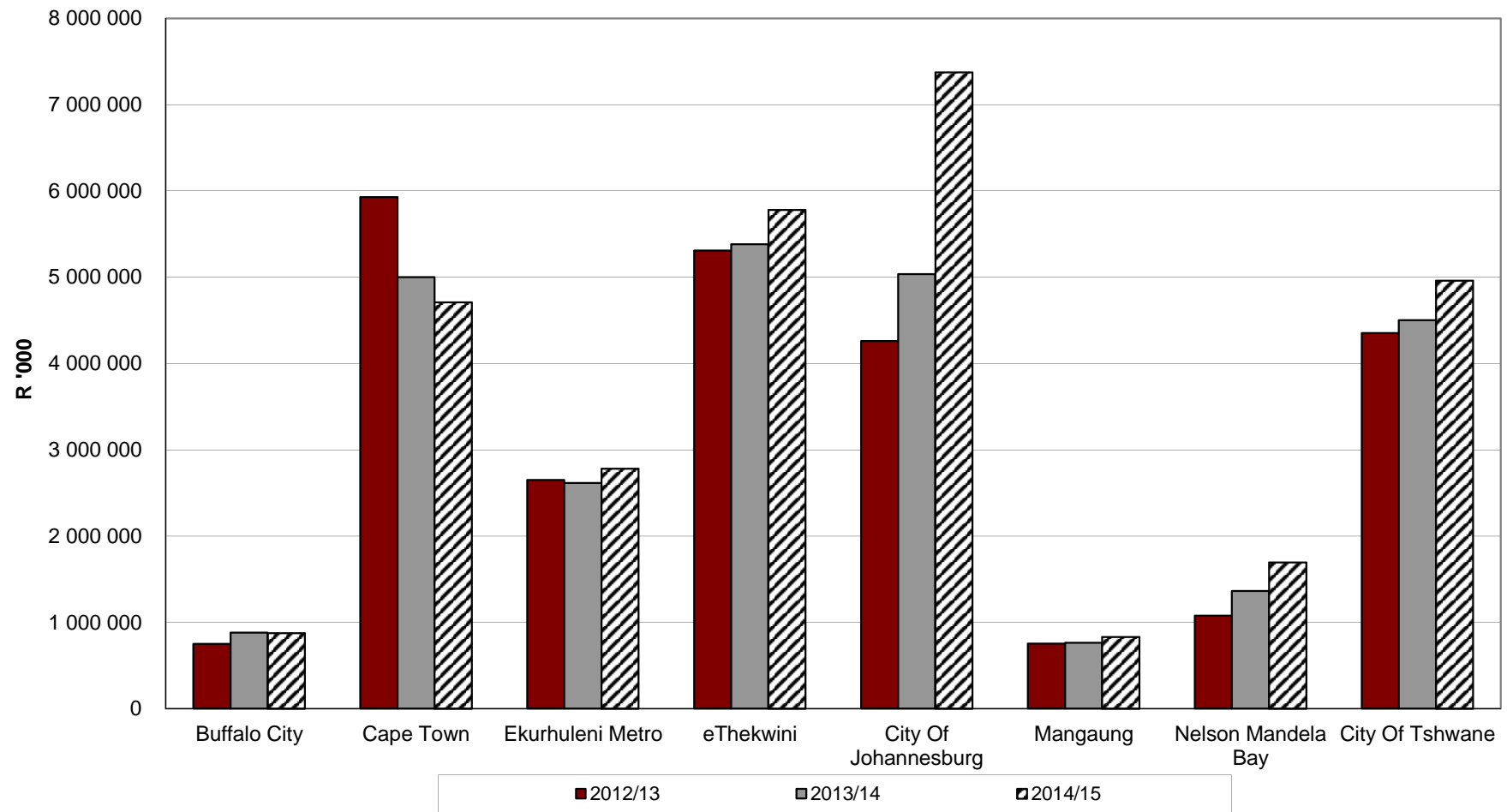
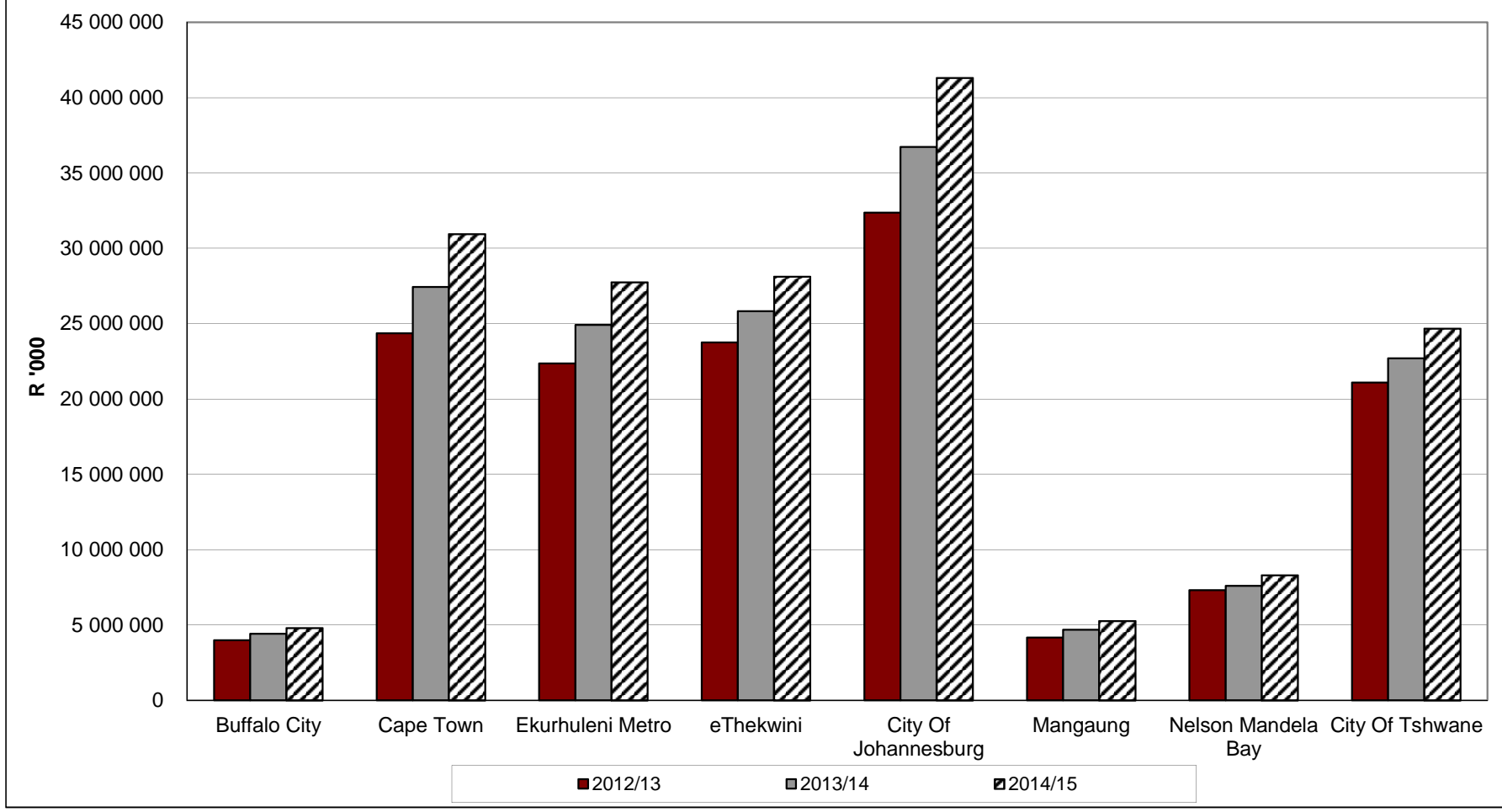
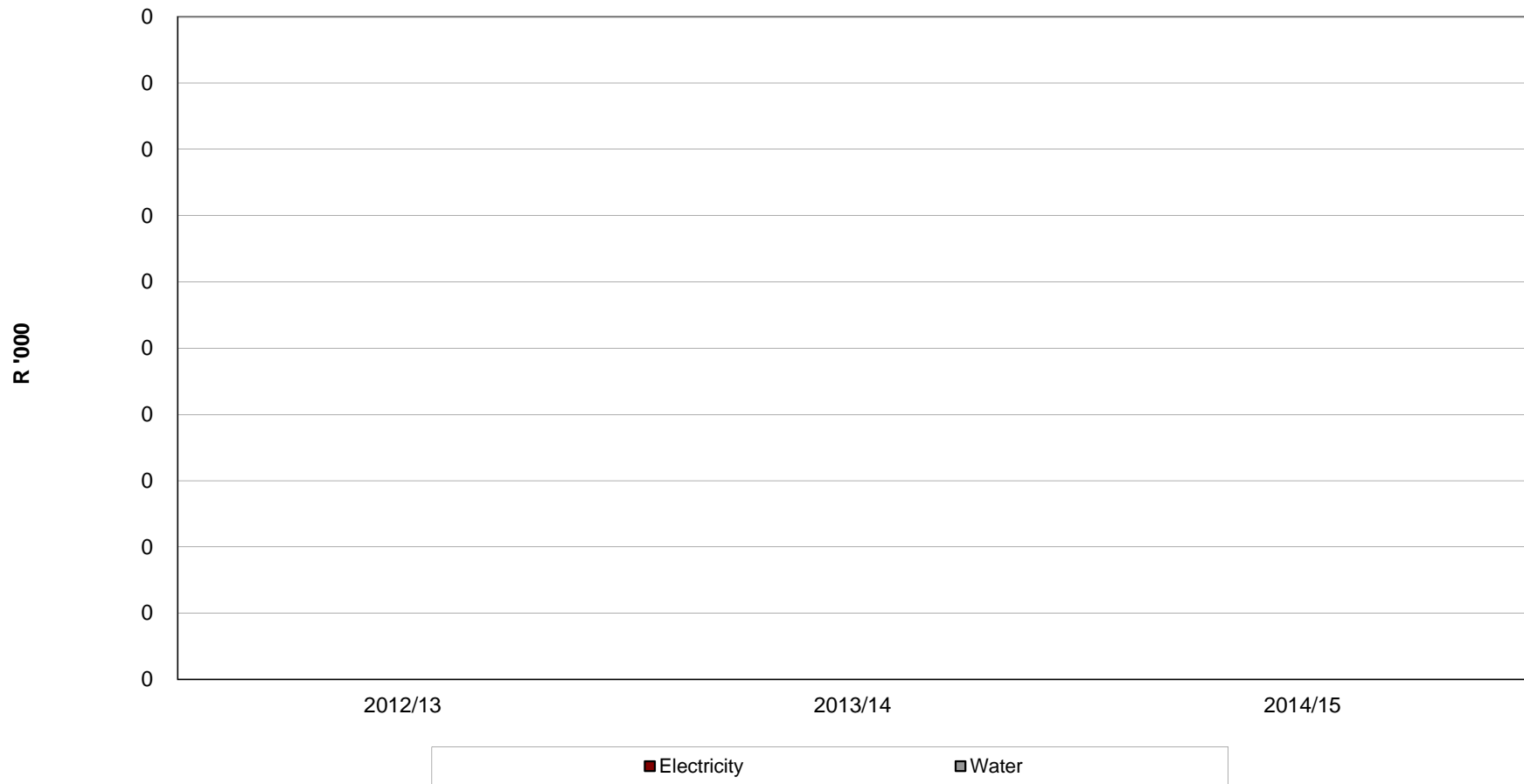


Figure 3.2: Budgeted operating expenditure per metro, 2012/13 - 2014/15

2012/13 - 2014/15**

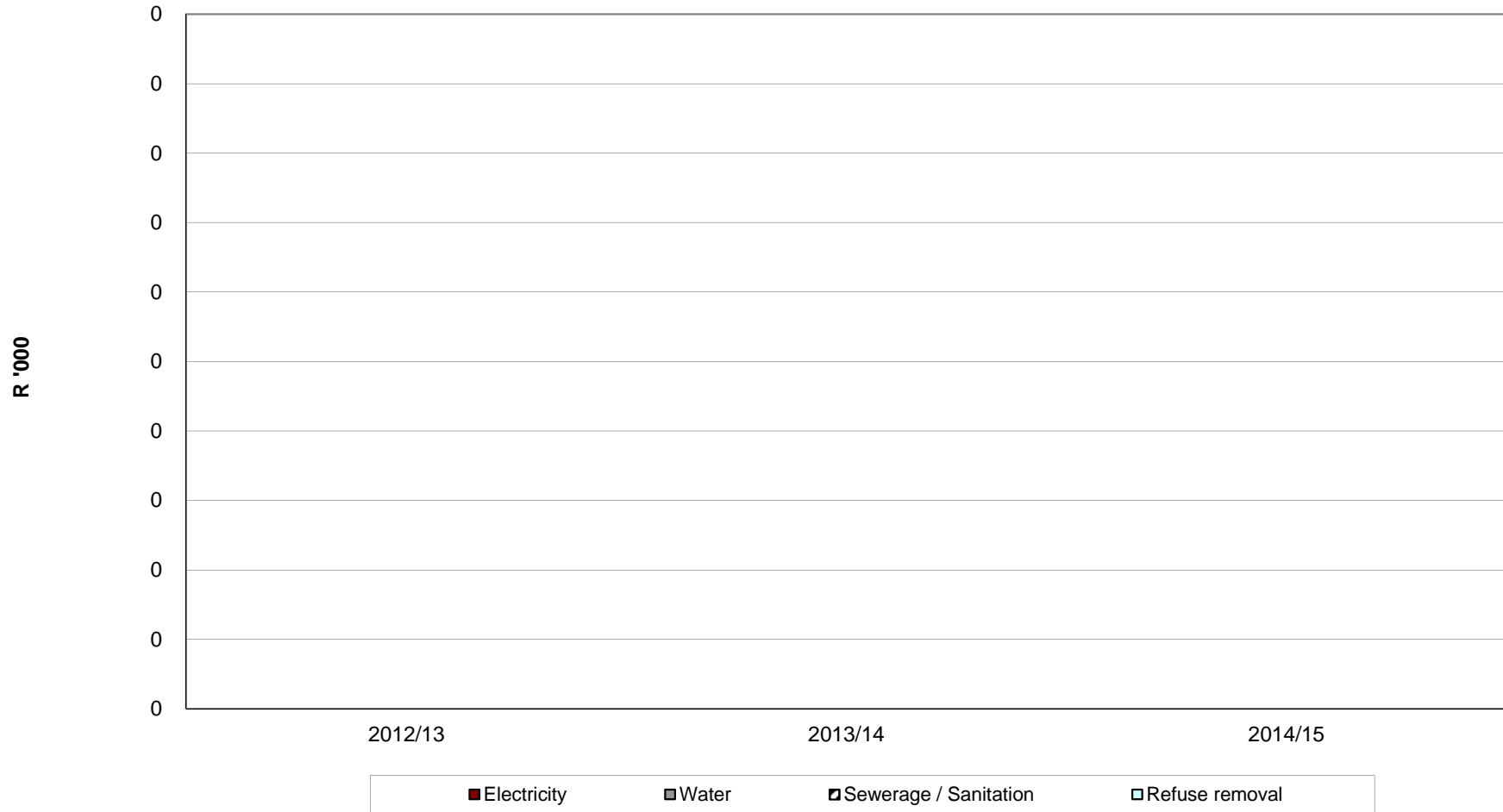


Figure 4.3: Aggregated budgeted expenditure for services by metros, 2012/13 - 2014/15

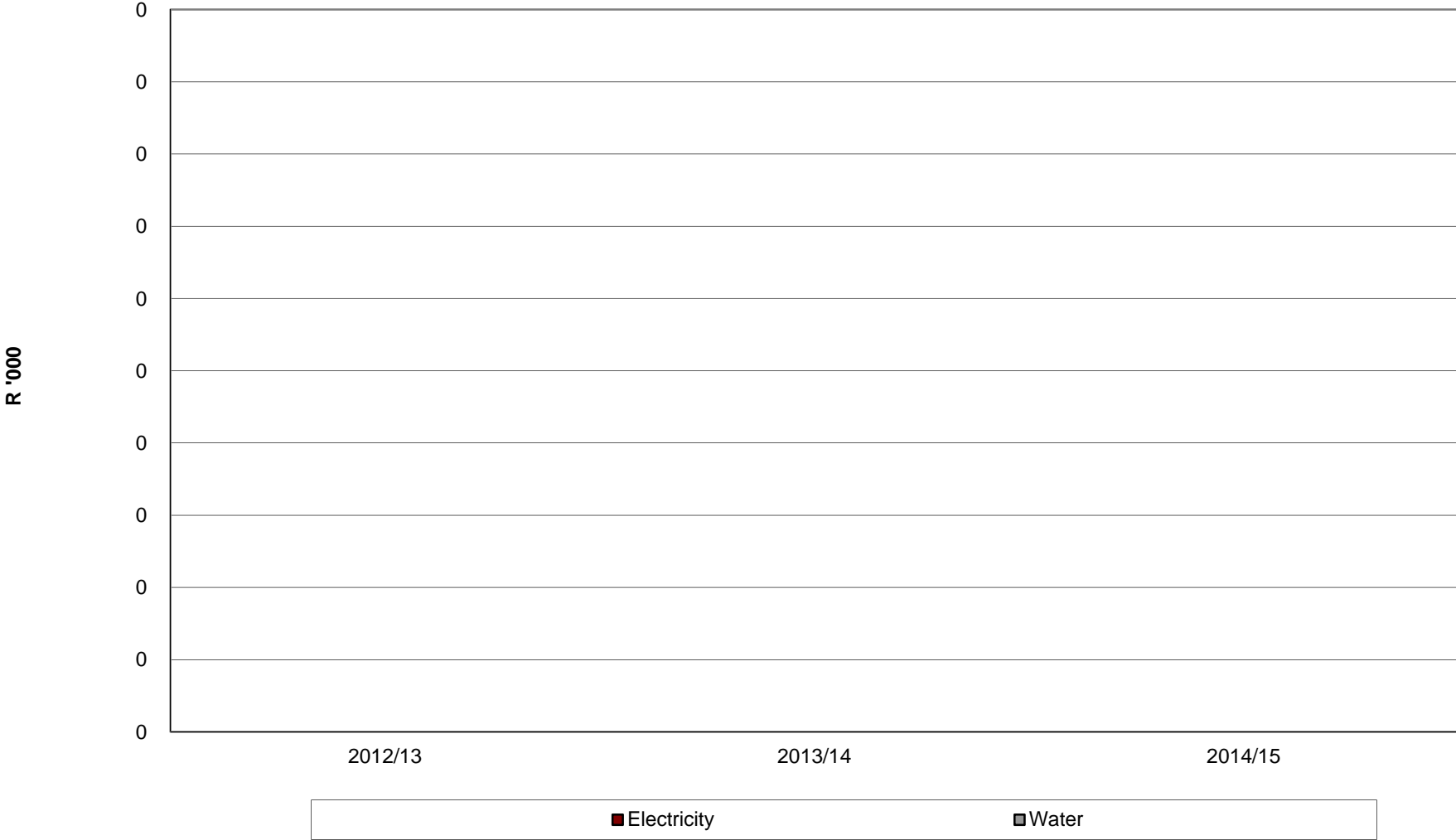


Figure 4.4: Aggregated budgeted revenue for services by metros, 2012/13 - 2014/15

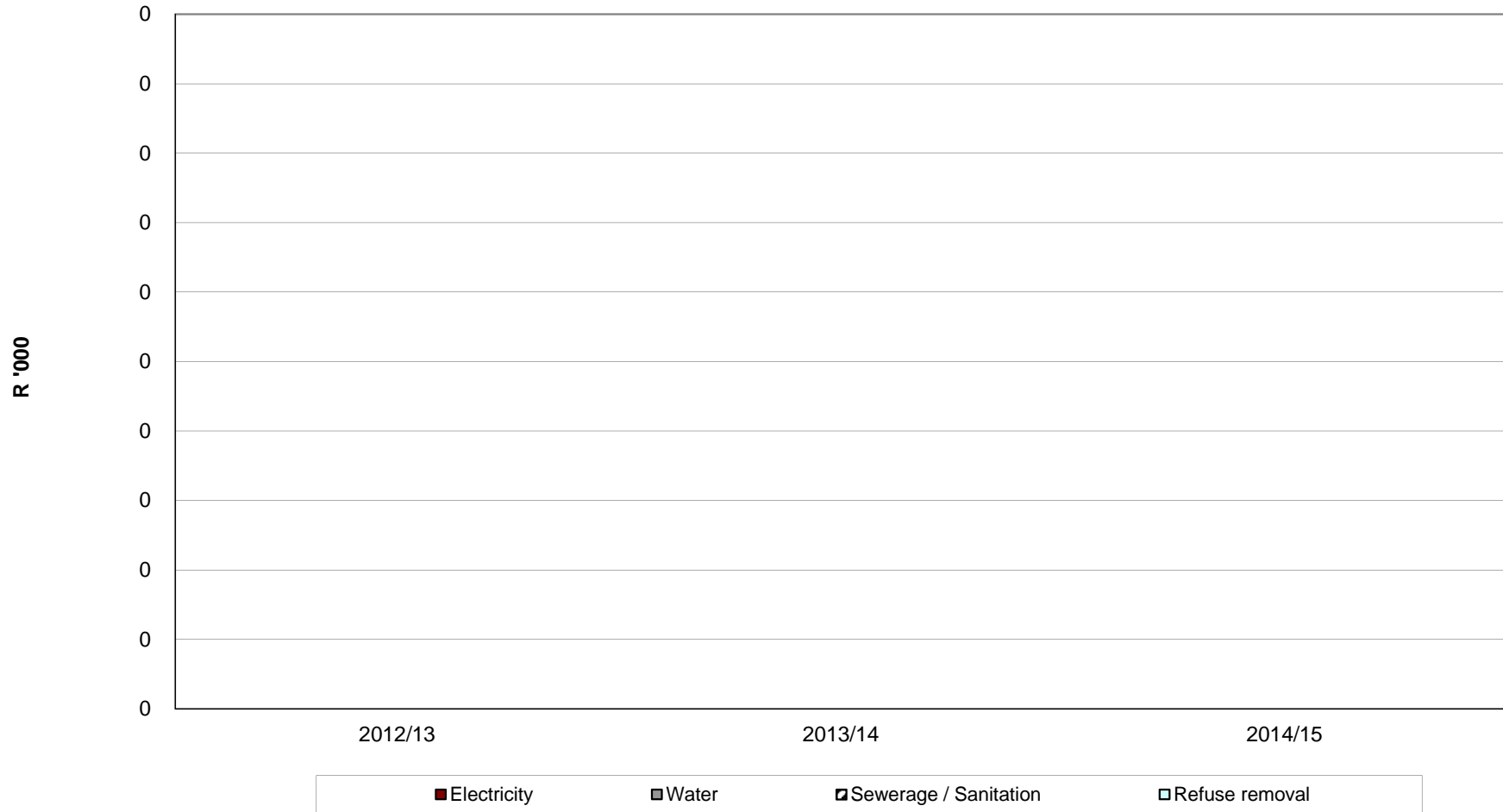


Figure 4.5: Aggregated budgeted expenditure for services by local municipalities, 2012/13 - 2014/15

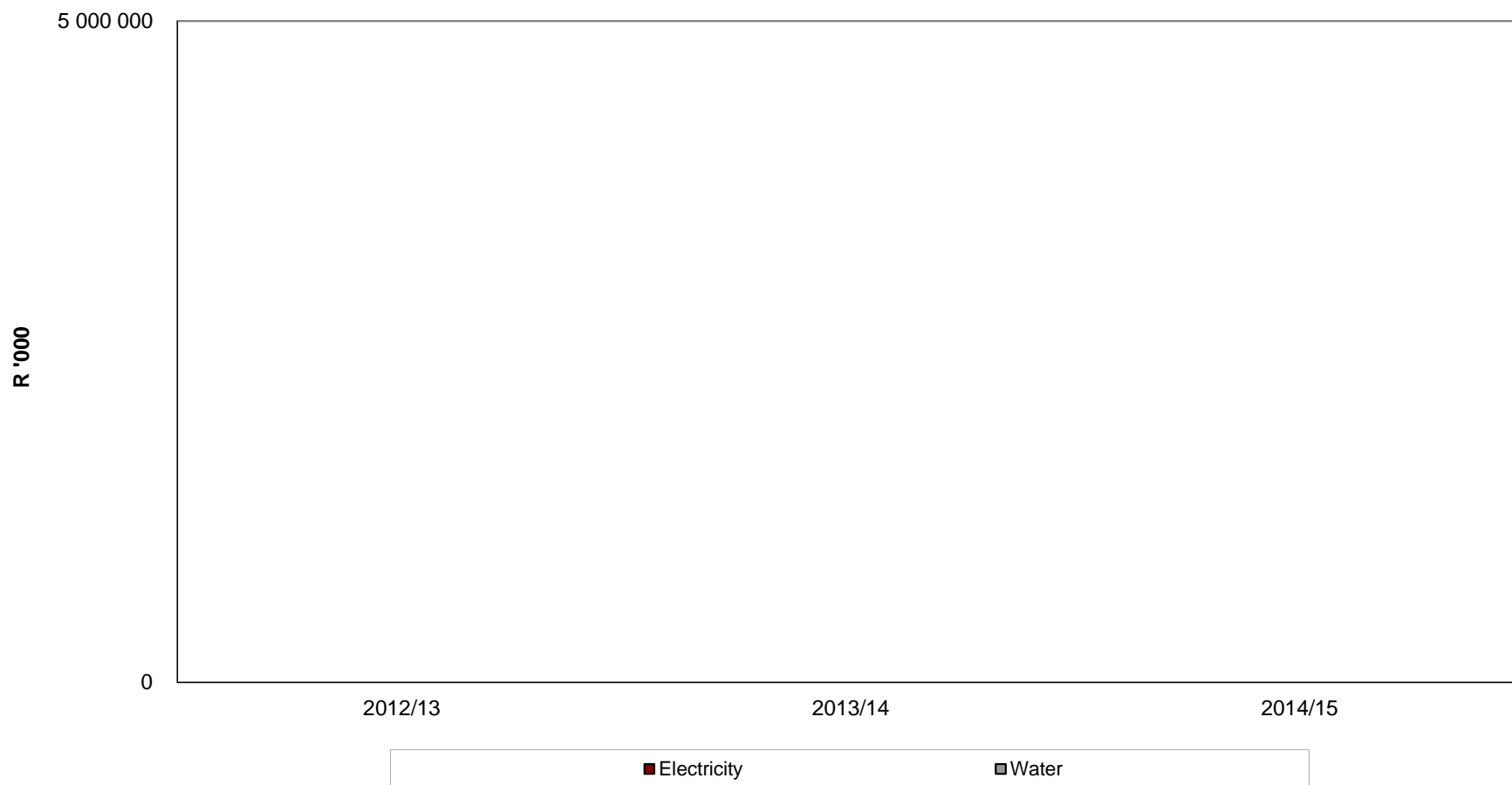


Figure 4.6: Aggregated budgeted revenue for services by local municipalities, 2012/13 - 2014/15

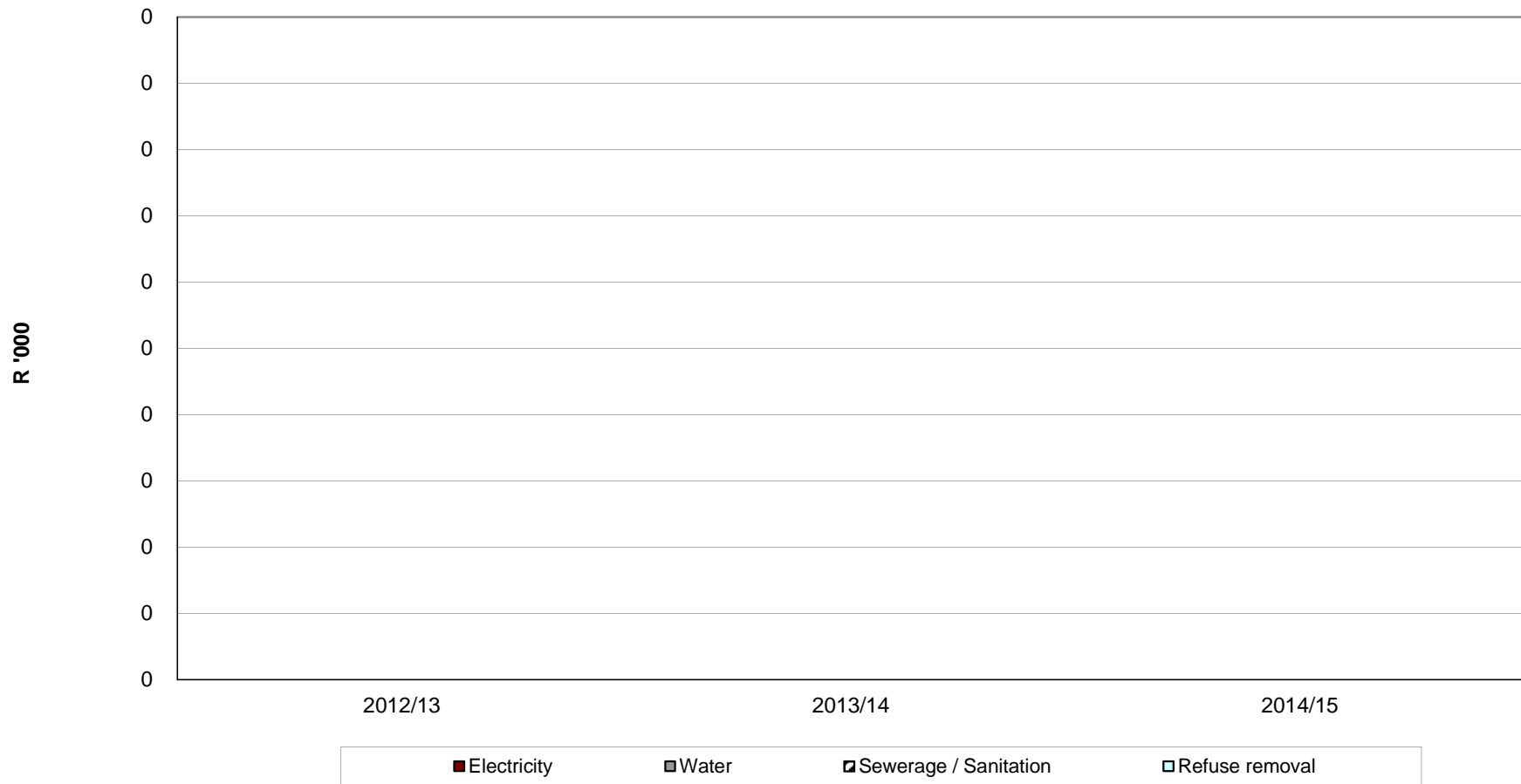


Figure 4.7: Aggregated budgeted expenditure for services by district municipalities, 2012/13 - 2014/15

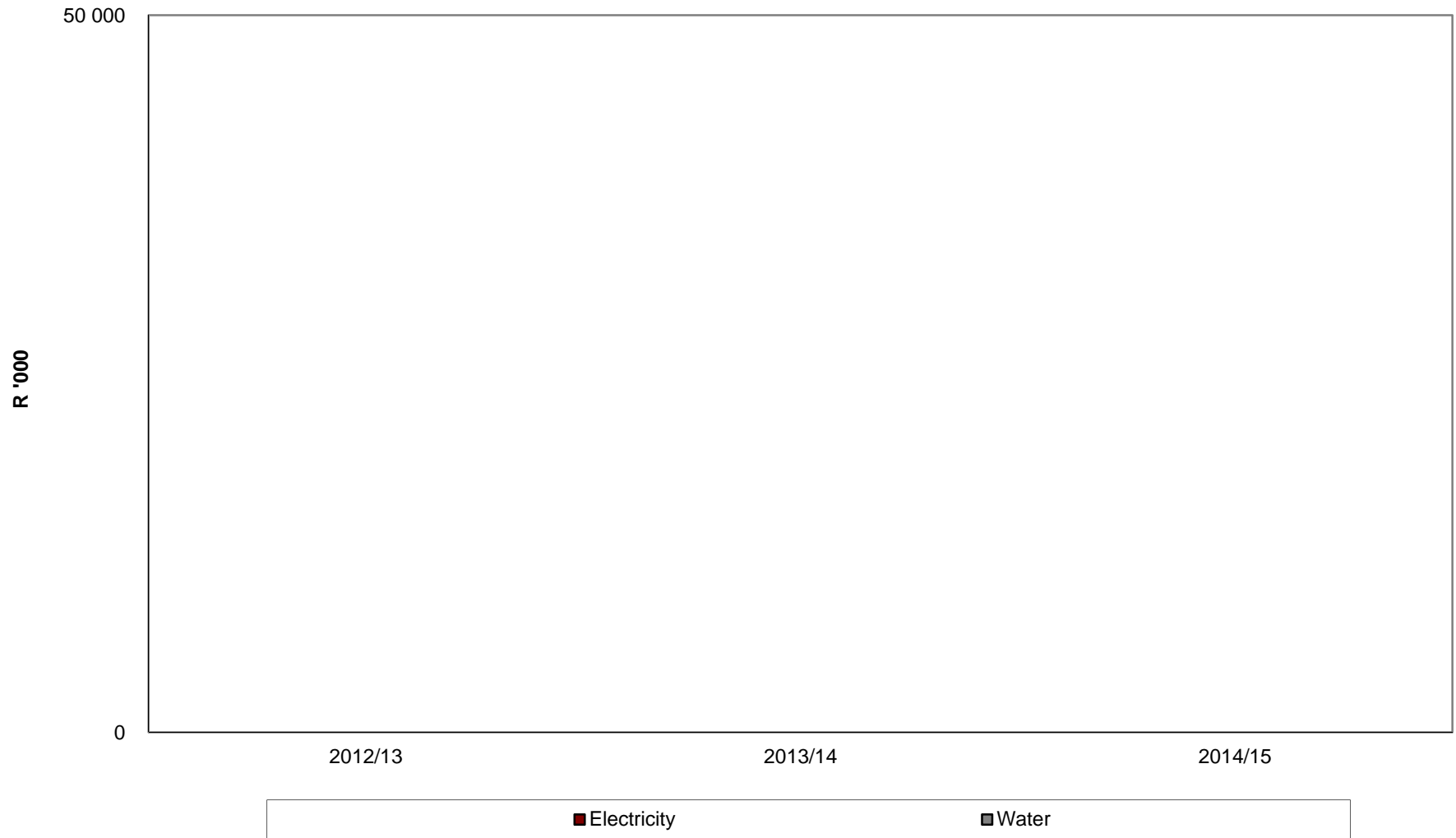
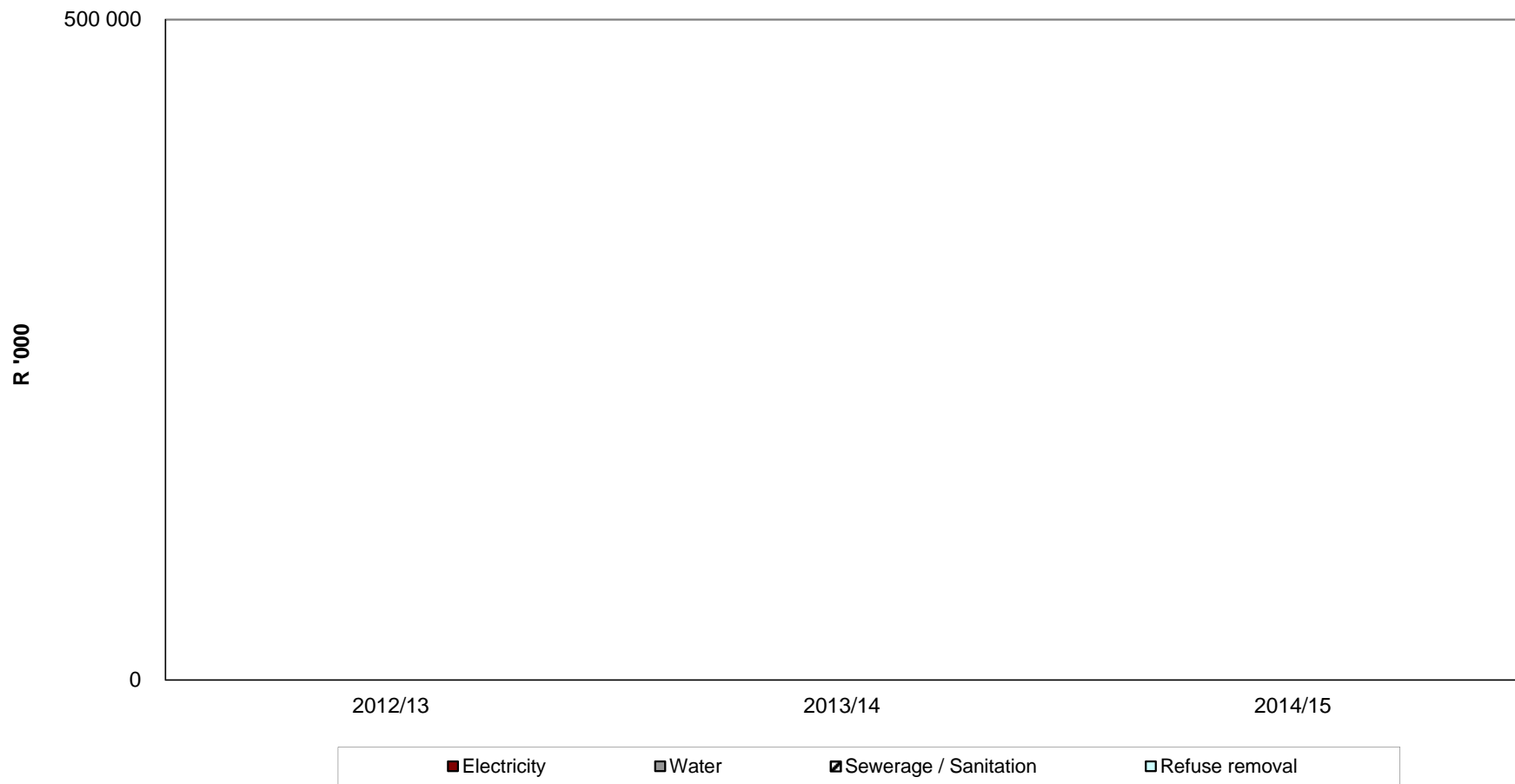
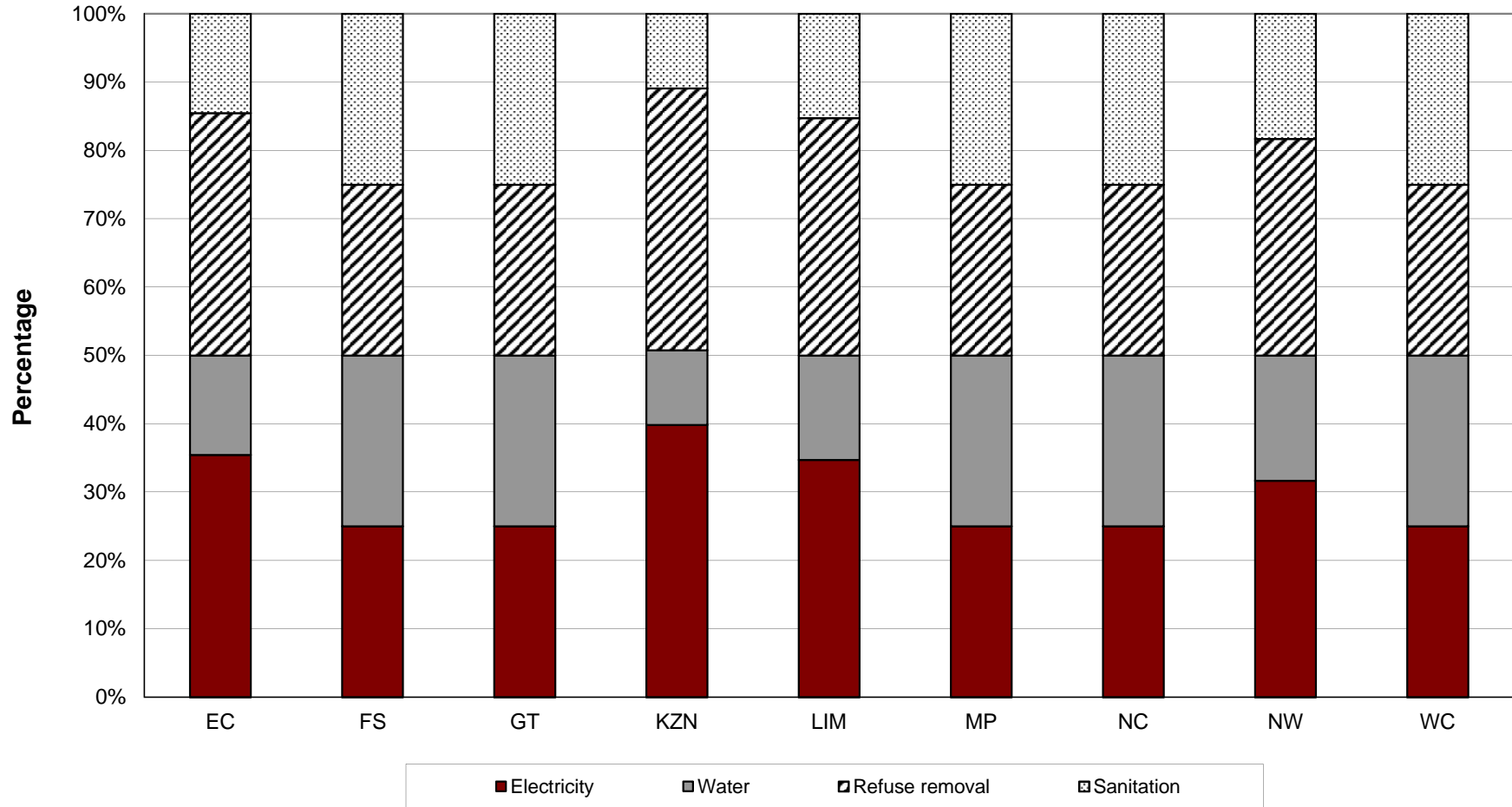


Figure 4.8: Aggregated budgeted revenue for services by district municipalities, 2012/13 - 2014/15



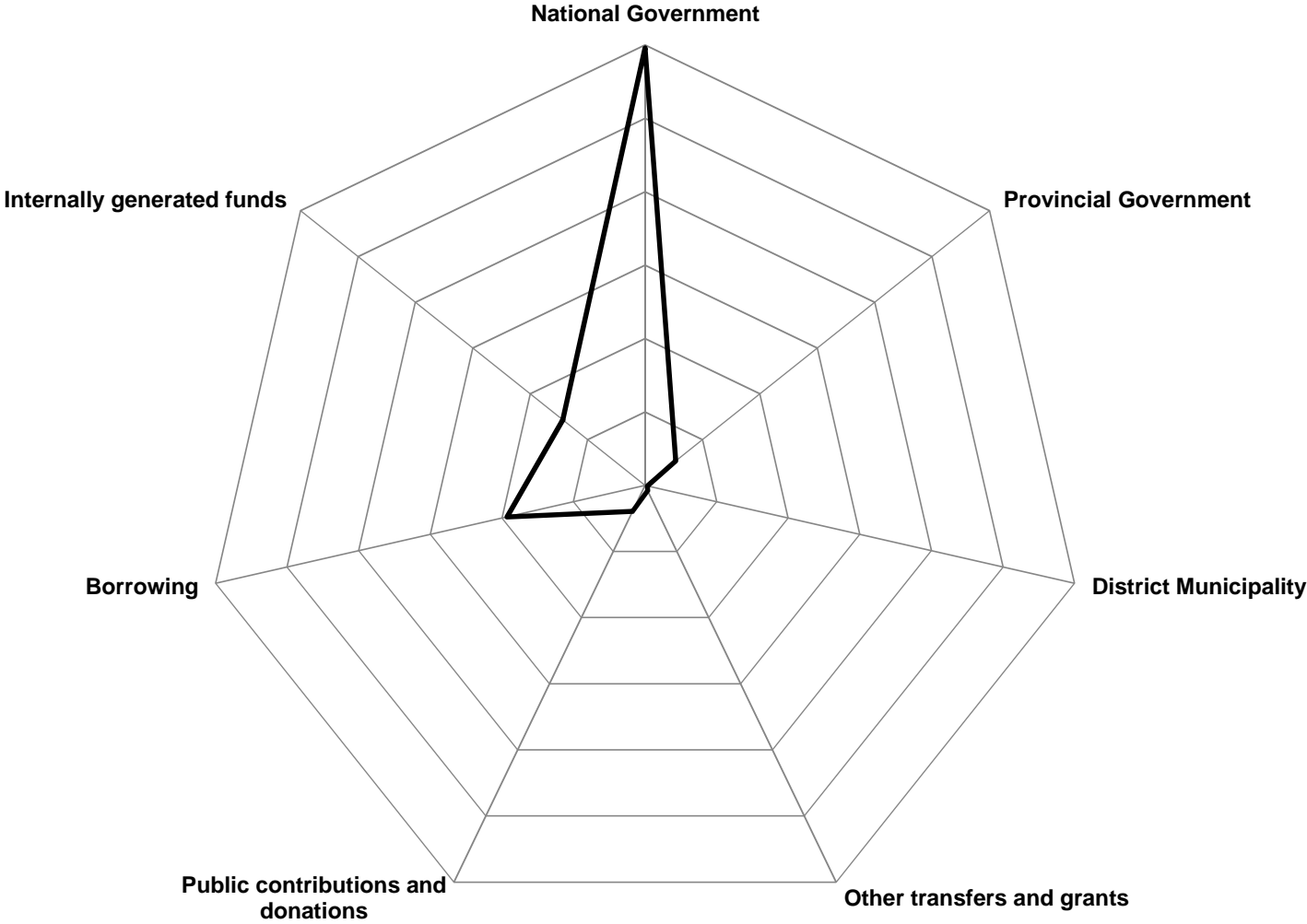
Figures 5: Powers and functions
