**STOPPING AND RE-ALLOCATION OF FUNDS IN TERMS OF THE 2018 DIVISION OF REVENUE ACT (ACT NO. 1 OF 2018)**

I, Tito Mboweni, Minister of Finance, acting in terms of section 16(2) and 26(2) of the 2018 Division of Revenue Act (Act No. 1 of 2018), hereby publish in the attached Explanatory Memorandum and Schedules:

- (a) The re-allocation of stopped conditional allocations between municipalities in terms of section 19 and 20 of the 2018 Division of Revenue Act; and
- (b) Technical adjustments on conditional allocations to municipalities.

For ease of reference only and where applicable, the attached Schedules reflect the main allocations, adjustments and total adjusted allocations.

**Explanatory Memorandum to the Allocations set out in the attached schedule**

This Gazette is published in terms of the 2018 Division of Revenue Act (Act No. 1 of 2018), and provides information regarding the adjustment of allocations to municipalities in the 2018/19 financial year.

This is necessitated by the need for the stopping and re-allocation of funds in terms of Section 19 and 20 of the 2018 Division of Revenue Act (DoRA).

**LOCAL GOVERNMENT****Stopping and re-allocation****Municipal Infrastructure Grant (MIG)**

1. Section 19 of DoRA stipulates that National Treasury may in its discretion or at the request of a transferring national officer stop the transfer for schedules 4 and 5 grants pertaining to anticipated under-spending on programmes or allocations in the financial year by the municipality.
2. National Treasury in consultation with the Department of Cooperative Governance (DCoG), concluded that municipalities reflecting significant uncommitted underspending would have their funds stopped within four provinces, namely: Eastern Cape, Free State, Northern Cape and North West, and re-allocated to the respective District Municipalities.

**The Municipal Emergency Housing Grant (MEHG)**

3. The Department of Human Settlements (DHS) in its submission to National Treasury, recommended that an allocation of an amount of R3.9 million is allocated through MEHG following a fire disaster that damaged most of the informal settlements within the Bitou LM in the Western Cape in order to fund the relocation costs and Transitional Residential Area units.
4. Following consultation with DHS in a letter dated 03 October 2018, it was approved by National Treasury that an amount of R3.9 million will be allocated to Bitou LM after the department declared a disaster against the municipality.

**The Neighbourhood Development Partnership Grant (NDPG)**

5. Following Msunduzi Local Municipality LM in KwaZulu-Natal province writing to the NDPG unit requesting that a portion of their 2018/19 NDPG allocation be stopped due to anticipated underspending owing to challenges the municipality is experiencing in implementing their NDPG projects. The NDPG unit wrote to Msunduzi LM in a letter dated 9 October 2018 approving the municipality's request that a portion of their NDPG allocation be stopped.
6. Based on Msunduzi LM's request, R27.4 million is stopped from Msunduzi LM's 2018/19 allocation and re-allocated to West Rand District Municipality (DM) in Gauteng province and City of Matlosana LM in North West province. West Rand DM will receive R20 million, while City of Matlosana LM will be allocated R7.4 million of the R27.4 million stopped from Msunduzi LM.

**Support afforded to municipalities reflecting significant underspending**

7. The municipalities that are affected by the stopping process due to governance and financial challenges will continue receiving support from NT, DCoG and the relevant stakeholders on the MIG cost reimbursement and invoice verification which has been ongoing in the current financial year.
