STOPPING AND RE-ALLOCATION OF FUNDS IN TERMS OF THE 2019 DIVISION OF REVENUE ACT (ACT NO. 16 OF 2019)

- I, Tito Titus Mboweni, Minister of Finance, acting in terms of section 16(2) and 26(2) of the 2019 Division of Revenue Act (Act No. 16 of 2019), hereby publish in the attached Explanatory Memorandum and Schedules:
 - (a) The re-allocation of stopped conditional allocations between municipalities in terms of sections 19 and 20 of the 2019 Division of Revenue Act;
 - (b) Conversion of allocations from direct to indirect in terms of section 21 of 2019 Division of Revenue Act; and
 - (c) Technical adjustments (correction of errors from previous gazettes) on conditional allocations to municipalities.

For ease of reference only and where applicable, the attached Schedules reflect the main allocations, adjustments and total adjusted allocations.

Explanatory Memorandum to the Allocations set out in the attached schedule

This Gazette is published in terms of the Division of Revenue Act, 2018, (Act No.16 of 2019) (DoRA) and provides information regarding the adjustment of allocations to municipalities in the 2019/20 financial year.

This is necessitated by the need for the stopping, re-allocation, conversion and correction of error in terms of Section 19 and 20 of the 2019 DoRA. Further, section 21 of the Act is also considered for purposes of converting direct conditional grants to indirect conditional grants.

RE-ALLOCATION OF FUNDS BETWEEN MUNICIPALITIES PER GRANT:

Integrated National Electrification Programme

1. The department of Energy (DoE) is stopping and re-allocating funds from Masilonyana Local Municipality (LM) to Lejweleputswa District Municipality (DM) under the Integrated National Electrification Programme (INEP 5B). Masilonyana LM and Lejweleputswa DM have entered into a Memorandum of Understanding wherein it was agreed that the district municipality will implement the electrification project on behalf of the local municipality with the assistance of the Municipal Infrastructure Support Agent (MISA) to verify the work done.

CONVERSION OF ALLOCATIONS

2. According to section 21 (2) (a) of the 2019 DoRA, National Treasury may, after consultation with the relevant transferring officer, receiving officer and provincial treasury, convert any portion of an allocation listed in Part B of Schedule 5 to one listed in Part B of Schedule 6 if it is satisfied that the conversion shall prevent under-expenditure or improve the level of service delivery in respect of the allocation in question or convert any portion of an allocation listed in Part B of Schedule 6 to one listed in Part B of Schedule 5.

Neighbourhood Development Partnership Grant

3. The Neighbourhood Development Partnership Programme within the National Treasury is converting funds under the Neighbourhood Development Partnership Grant (NDPG) due to anticipated underspending. The 2019/20 NDPG 5B allocations for West Rand DM and Emfuleni LM will be converted from Part B of Schedule 5 to Part B of Schedule 6.

THE MUNICIPAL EMERGENCY HOUSING GRANT:

4. An amount of R149.1 million is allocated to Eastern Cape and Kwa-Zulu Natal municipalities after the Department of Human Settlements (DHS) declared a disaster in municipalities in these provinces. The allocation is done through the Municipal Emergency Housing Grant (MEHG) for the emergency relief to fund the temporary shelters following various disaster incidents namely fire and severe rain that damages and affected home owners.

CORRECTION OF AN ERROR

- According to section 16 (2) of the 2019 DoRA, for purposes of correcting an error or omission in an allocation or framework published, the National Treasury must on its initiative and after consultation with the relevant transferring officer by notice in the Gazette amend the affected allocation or framework.
- 6. Magareng LM, Emthanjeni LM and Prince Albert LM in the Northern Cape and Western Cape province respectively had their 2019/20 MIG erroneously allocated in the section 16 gazette. The MIG allocation for Prince Albert LM did not take into account the final sport allocation of R3.6 million which was allocated to Magareng (R2 million) and Emthanjeni (R1.6 million).
