NATIONAL TREASURY**NO. 7215****11 March 2026**

I, Enoch Godongwana, Minister of Finance, in my capacity as the Minister of Finance, hereby publish, in accordance with sections 15 and 25 of the Division of Revenue Act, 2025 (Act No. 2 of 2025) (DoRA) as amended by the Division of Revenue Amendment Act, 2025 (Act No. 12 of 2025) (DoRAA), the attached Explanatory Memorandum, Schedules and the local government conditional grant frameworks:

- (a) Additional allocations for the Municipal Disaster Recovery Grant and the Urban Development Financing Grant;
- (b) Rollover under the Public Transport Network Grant;
- (c) Amendments to the Frameworks for conditional grants to municipalities; and
- (d) The stopping and re-allocation of conditional grants to municipalities made in terms of sections 18 and 19.

For ease of reference only and where applicable, the attached Schedules reflect the main allocations, adjustments, and total adjusted allocations.

Explanatory Memorandum to the Allocations set out in the attached Schedule

This Gazette is published in terms of section 15 of the Division of Revenue Act, 2025 (Act No. 2 of 2025) (DoRA) as amended by the Division of Revenue Amendment Act, 2025 (Act No. 12 of 2025). It provides information regarding the adjustment of allocations made to municipalities in the 2025/26 financial year during the mid-year adjustments.

An adjustments budget provides for unforeseen and unavoidable expenditure; appropriation of monies already announced during the tabling of the annual budget (but not allocated at that stage); the shifting of funds between and within votes where a function is transferred; the utilisation of savings and the roll-over of unspent funds from the preceding financial year.

It further provides for the stopping and reallocation of funds to municipalities and reallocated to their districts in terms of sections 18 and 19 of 2025 DoRA.

CHANGES TO LOCAL GOVERNMENT ALLOCATIONS

Additional funding to the Municipal Disaster Recovery Grant

An additional R496 million is allocated to the Municipal Disaster Recovery Grant (MDRG) to fund the reconstruction and rehabilitation of municipal infrastructure that was damaged by the floods that occurred in the Eastern Cape between March and June 2025.

Additional funding to the Urban Development Financing Grant

An additional R2.1 billion is provided to the Urban Development Financing Grant to strengthen the metro trading services component.

Roll over of funds in the Public Transport Network Grant

An amount of R303 million is rolled over in the Public Transport Network Grant to enable the eThekweni Metropolitan Municipality to proceed with essential work needed to make Corridor 3 of its Integrated Public Transport Network operational.

CHANGES TO CONDITIONAL GRANT FRAMEWORKS AND ALLOCATIONS

The framework of the MDRG (Recovery) is amended to ring-fence the additional funds for the reconstruction and rehabilitation of damaged municipal infrastructure and the framework of the Urban Development Financing Grant is amended to reflect the revised 2025/26 baseline following the additional R2.1 billion for metro trading services.

STOPPING AND REALLOCATION

The Department of Cooperative Governance (DCoG) requested the National Treasury to intervene regarding the Impendle Local Municipality in KwaZulu-Natal, which has been unable to spend its Municipal Infrastructure Grant (MIG) and MDRG allocations in line with the grant framework conditions. As a result, the remaining 2025/26 financial year funds will be reallocated to the uMgungundlovu District Municipality to implement the projects on Impendle's behalf. In addition, the Smart Meters Grant will be re-gazetted to reallocate funding to municipalities that have demonstrated implementation readiness, following assessments which confirmed that only 11 municipalities have complete and approved business plans for the 2025/26 financial year.
